153/18 Funding Agreement – Church Street Car Parking

Members considered whether to extend the free parking scheme beyond the anniversary date of 17th January 2019. Cllr Boaler noted that it was agreed last year that the scheme would be renewed for another 12 months. There are funds allocated in the budget for this scheme.
